## **Terms & Conditions of Use**

- 1. I have a current unencumbered driver's licence and am authorised to drive motor vehicles including the vehicle type being tested/loaned. I agree to provide a copy of my licence.
- 2. I am not disqualified from driving, nor from obtaining a driver's licence. My driver's licence at the time of the signing this declaration is not suspended nor revoked.
- 3. I will take full responsibility for any and all charges incurred while the vehicle is in my possession. This includes all speed camera fines, parking infringement notices and any other infringement of which I might be liable under the Land Transport Act 1998 and associated regulations.
- 4. In the event that the vehicle is damaged while the vehicle is in my possession, and I or the driver are found to be under the influence of alcohol or drugs and/or found guilty of driving in a dangerous, culpable, or negligent manner (voiding insurance), I will be solely and wholly responsible for the total cost of repairs to the vehicle plus any damage to other persons or property.
- 5. I accept responsibility for the first \$1,000.00 of insurance claim excess (or \$1,350.00 for drivers under the age of 25 years) for damage sustained to the vehicle should it suffer an accident while in my possession.
- 6. I warrant that any other person who may drive the vehicle while it is in my possession satisfies the provisions of clauses 1 and 2 above. I accept that allowing another person to drive the vehicle while it is in my possession does not absolve me of any responsibility under these terms and conditions.
- 7. I agree no eating, drinking, smoking, vaping, or pets in the vehicle. Grooming or repair charges will apply if the vehicle is returned in an unreasonable condition.
- 8. I accept that if there is excessive unauthorised use of the vehicle while in my possession, the costs of wear and tear, millage and fuel charges will apply.
- 9. I will return the vehicle to the dealership at the agreed date and time (recorded above). Notwithstanding the agreed vehicle return date, I agree to return the vehicle to the dealer on demand, if requested by the dealership.
- 10. All driving of the vehicle will occur in the Christchurch area. Driving to another region must be prior agreed, and details documented on this form (record below).
- 11. If I am using the vehicle for my work, I will only use the vehicle within its capability. I will ensure I carry any required safety equipment necessary for my work. The dealership is not responsible for my work safety beyond the vehicle's roadworthiness.
- 12. If using the vehicle for commercial purposes, I accept that my own insurance may be called upon, in the first instance, for a claim event.
- 13. To the greatest extent permitted by law, neither the dealership, nor any related company or associated person or party of either of them will be liable for any loss, damage or injury suffered or sustained (including, but not limited to, consequential loss) as a result of the loan/test drive, except for any liability which cannot be excluded by law.
